

Clinical Policy: Idelalisib (Zydelig)

Description

Idelalisib (Zydelig[®]) is a kinase inhibitor.

FDA Approved Indication(s)

Zydelig is indicated for the treatment of relapsed chronic lymphocytic leukemia (CLL), in combination with rituximab, in patients for whom rituximab alone would be considered appropriate therapy due to other co-morbidities.

Limitation(s) of use:

- Zydelig is not indicated and is not recommended for first-line treatment of any patient, including patients with CLL, small lymphocytic lymphoma (SLL), follicular lymphoma (FL), and other indolent non-Hodgkin lymphomas.
- Zydelig is not indicated and is not recommended in combination with bendamustine and rituximab, or in combination with rituximab for the treatment of patients with FL, SLL, and other indolent non-Hodgkin lymphomas.

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that Zydelig is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

- A. Chronic Lymphocytic Leukemia (must meet all):
 - 1. Diagnosis of CLL;
 - 2. Prescribed by or in consultation with an oncologist or hematologist;
 - 3. Age \geq 18 years;
 - 4. Disease is relapsed or refractory after prior therapy with both of the following (a and b; *see Appendix B for examples*);*
 - a. BTK inihibitor (e.g., Calquence[®], Brukinsa[®], Imbruvica[®], Jayprica[®]);
 - b. Venclexta[®];

*Prior authorization may be required.

- 5. Prescribed as a single agent or in combination with rituximab;
- 6. For Zydelig requests, member must use idelalisib, if available, unless contraindicated or clinically significant adverse effects are experienced;



- 7. Request meets one of the following (a or b):*
 - a. Dose does not exceed (i and ii):
 - i. 300 mg per day;
 - ii. 2 tablets per day;
 - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

*Prescribed regimen must be FDA-approved or recommended by NCCN.

Approval duration:

Medicaid/HIM - 6 months

Commercial – 12 months or duration of request, whichever is less

B. Small Lymphocytic Leukemia (off-label) (must meet all):

- 1. Diagnosis of SLL;
- 2. Prescribed by or in consultation with an oncologist or hematologist;
- 3. Age \geq 18 years;
- 4. Disease is relapsed or refractory after prior therapy with both of the following (a and b; *see Appendix B for examples*);*
 - a. BTK inihibitor (e.g., Calquence[®], Brukinsa[®], Imbruvica[®], Jayprica[®]);
 b. Venclexta[®];

*Prior authorization may be required.

- 5. Prescribed as a single agent or in combination with rituximab;
- 6. For Zydelig requests, member must use idelalisib, if available, unless contraindicated or clinically significant adverse effects are experienced;
- 7. Request meets one of the following (a or b):*
 - a. Dose does not exceed (i and ii):
 - i. 300 mg per day;
 - ii. 2 tablets per day;
 - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

*Prescribed regimen must be FDA-approved or recommended by NCCN.

Approval duration:

Medicaid/HIM – 6 months

Commercial – 12 months or duration of request, whichever is less

C. Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or



2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

II. Continued Therapy

- A. All Indications in Section I (must meet all):
 - 1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Zydelig for a covered indication and has received this medication for at least 30 days;
 - 2. Member is responding positively to therapy;
 - 3. For Zydelig requests, member must use idelalisib, if available, unless contraindicated or clinically significant adverse effects are experienced;
 - 4. If request is for a dose increase, request meets one of the following (a or b):*
 - a. New dose does not exceed (i and ii):
 - i. 300 mg per day;
 - ii. 2 tablets per day;
 - b. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).
 *Prescribed regimen must be FDA-approved or recommended by NCCN.

Approval duration:

Medicaid/HIM - 12 months

Commercial - 12 months or duration of request, whichever is less

B. Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies –



CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid or evidence of coverage documents.

- Contraindication(s): history of serious allergic reactions including anaphylaxis and toxic epidermal necrolysis
- Boxed warning(s): fatal and serious toxicities hepatic, severe diarrhea, colitis, pneumonitis, infections, and intestinal perforation
